Form fields instructions

- (1) First Name - Write your first name exactly as it appears on your passport or ID document.
- (2) Last Name - Write your full family name or surname as it appears on your official documents.
- (3) Italian Tax Code - The Codice Fiscale is an alphanumeric code issued by the Italian Revenue Agency (Agenzia delle Entrate), similar to a Social Security Number. If you don't have one yet, visit: <https://www.agenziaentrate.gov.it/portale/web/english/nse/individuals/tax-identification-number-for-foreign-citizens>
- (4) Course degree - Indicate the name or type of degree program in which you are enrolled (e.g., Bachelor's in Economics, Master's in Engineering).
- (5) University ID – Matricola - Write the ID number assigned to you by your university. If you haven't received it yet, write 999999.
- (6) Household Composition - List all the individuals who live with you at your residence. This typically includes immediate family members such as parents or siblings, and anyone officially residing in your household.
- (7) Number of people - Indicate the total number of people listed in the household composition.
- (8) Relationship - Describe the relationship each person has with you (e.g., mother, father, sibling, roommate).
- (9) Born in - For each person listed, write their place of birth (city and country).
- (10) Born on - For each person listed, write their full date of birth (DD/MM/YYYY).
- (11) Are your parents divorced? - Select "YES" or "NO". This helps determine which parent's information to consider for ISEE purposes.
- (12) If yes, what is the address of the parent who does not live with you - Provide the full residential address (street, city, postal code, country) of the parent not living in your household.
- (13) Housing status - Indicate whether your current residence is Owned or Rented.
- (14) Is your current residence rented? - Tick the appropriate box to confirm if the house you live in is rented.
- (15) Who pays the rent? - Specify the name(s) of the person(s) responsible for paying the rent.
- (16) What was the total amount paid in 2025? - Enter the total amount of rent paid for the year 2025, in Euros.
- (17) Is your current residence owned? - Tick "YES" if the property is owned (by you or someone else); otherwise, tick "NO".
- (18) Ownership details - If the house is owned, list every owner and specify their percentage of ownership. Also indicate the size of the dwelling in square meters.
- (19) Household Finance - This section refers to the total value of financial assets as of 31 December 2024. Include information for yourself and every household member listed in section 6.
- (20) Owner - Write the name of the person who owns the financial asset (yourself or another household member).
- (21) Asset kind - Indicate the type of asset (e.g., banking account, checking account, savings account, investment fund, securities).
- (22) Total amount - State the total value in Euros of each asset held as of 31 December 2024. If you or a household member own no assets, write "zero".
